Health Tests Required of all Before Marriage

Brides and grooms in the ¹UAE will soon have to prove to the court magistrate marrying them that they have shown each other the results of eight mandatory health tests before they will be allowed to tie the knot.

A new law is being drafted, part of the Health Minister's decree 214 for 2006, to ensure that no one goes into a marriage ignorant of the fact that their partner could be carrying HIV, hepatitis B, hepatitis C, syphilis, tuberculosis, blood group RH, sickle-cell anaemia or thalassaemia.

"The judge will not perform the marriage unless he has the medical reports from both. The bride and groom also have to see each other's results," said Dr Amin Al Amiri, director of Blood Transfusion and Research services and co-chairman of the UAE's Higher Scientific Committee for Premarital tests.

The test applies to any person, of any nationality or religion, who is looking to marry within the UAE.

"But no one will stop anyone from marrying, even if they test positive for a number of the illnesses. It is a human right to marry, but they must know their results," the official added.

"The aim of this protocol is to protect the community from having children with diseases, such as serological problems or blood disorders. Secondly, we want to protect couples from the serology and viral diseases transmitted through sexual contact.

"We are working for the sake of the community and for the sake of the inhabitants of the UAE to have healthy people in the country, regardless of nationality, religion, age or colour," Al Amiri explained.

As part of the decree, the Ministry of Health will also offer help to those who test positive for any of the eight conditions.

"We want to give them the guidelines and protection strategies. If we find one or both are infected with any type of disease, our responsibility is to provide them with the vaccination and treatment needed," the official added.

The committee is to meet next week to finalise the network and infrastructure needed to enforce the ruling.

"There are a certain number of things to be done before centralising the tests in the country. There is no need to be impulsive, we want to do it in a proper way and precisely," Al Amiri added.

He said other diseases, conditions and genes may also be added to the list for testing, depending on the need.
